

ARTICLES OF INCORPORATION  
OF  
ASHLEY-AYRES EVANGELISTIC ASSOCIATION, INC.

79 of May 1964  
Director, Charter Division

We, the undersigned natural persons of the age of twenty-one years or more, at least two of whom are citizens of the State of Texas, acting as incorporators of a corporation under the Texas Non-Profit Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE ONE

The name of the corporation is "ASHLEY-AYRES EVANGELISTIC ASSOCIATION, INC."

ARTICLE TWO

The corporation is a non-profit corporation.

ARTICLE THREE

The period of its duration is perpetual.

ARTICLE FOUR

The purpose or purposes for which the corporation is organized are:

"To promote the cause of the Christian Religion by engaging in Evangelistic and Missionary work.

In general, to carry on any other affairs in connection with the foregoing, to exercise any rights or privileges incident to or reasonably necessary or convenient to accomplish the purposes of this association, and to exercise the General Powers for non-profit corporations as outlined in Article 2.02 of the Texas Non-Profit Corporation Act."

ARTICLE FIVE

The corporation has no members.

ARTICLE SIX

The street address of the initial registered office of the corporation is 4303 Knotty Oaks Trail, Houston, Harris County, Texas, and the name of its initial registered agent at such address is JAMES HARLIE AYRES.

ARTICLE SEVEN

The number of directors constituting the initial board of directors of the corporation is three and the names and addresses of the persons who are to serve as the initial directors are:

ARTICLE NINE

In the event of dissolution of the ASHLEY-AYRES EVANGELISTIC ASSOCIATION, INC., all assets of the corporation, after the payment of all outstanding debts and obligations, shall vest in a similar non-profit religious corporation.

ARTICLE TEN

The power to alter, amend, or repeal the by-laws or to adopt new by-laws shall be vested in the board of directors. The by-laws may contain any provisions for the regulation and management of the affairs of a corporation not inconsistent with law or with the articles of incorporation.
