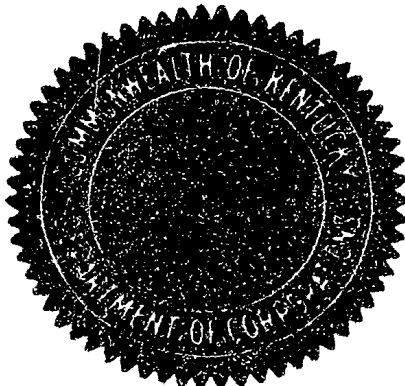

KNOW ALL MEN BY THESE PRESENTS:

That a group of citizens have voluntarily associated themselves together for the purpose of forming a non-profit organization and do hereby adopt Articles of Incorporation as follows:

ARTICLE I

The name of the corporation shall be Ordinary People National, Inc..

ARTICLE II

The duration of same shall be perpetual.

ARTICLE III

The purpose of the corporation is and shall be to provide Christian broadcasting of various Christian ministries as follows:

The Corporation shall receive the right to duplicate all materials of said ministries and agencies for resale at reasonable prices for compensation for production and promotion of said ministries and agencies.

#### ARTICLE IV

This corporation is organized exclusively for charitable and educational purposes, including for such purposes, the making and distributing to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code of 1954 and any amendments thereto.

#### ARTICLE V

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to, its members, directors, officers, or other private persons, except that the corporation shall

be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1954 (or the corresponding provision of any further United States Internal Revenue Law).

#### ARTICLE VI

The registered office of the corporation will be located on the Milltown Route, Highway 61 North, Columbia, Ky. 42728 and the initial registered agent shall be Larry Ervin, Milltown Route, Highway 61 North, Columbia, Ky. 42728.

#### ARTICLE VII

The number of directors constituting the initial Board of Directors

#### ARTICLE IX

The private property of each Board of Director and Incorporator shall not be liable for any debts or liabilities of the corporation.

#### ARTICLE X

Upon the dissolution of the corporation, the Board of Directors, shall, after paying or making provision for the payment of all the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purpose of the corporation in such manner, or to such organization or organizations organized and operated

exclusively for charitable, education, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue law) or to the City of Campbellville, Kentucky for recreational use, as the Board of Directors shall determine.

#### ARTICLE XI

This corporation shall have no members and the affairs of the corporation shall be managed exclusively by the Board of Directors or to such other officers as may be authorized and empowered by the By-Laws.


#### ARTICLE XII




